### **Village Awareness Programme**



> To disseminate the benefits of activities under NDP I

- Objective
  - Creating awareness among milk producers about the benefits of NDP I interventions (VBMPS/RBP/FD ) with *real examples*
  - Information to milk producers on scientific animal husbandry and dairying practices
- Eligible EIAs
  - Dairy cooperatives implementing sub projects of RBP/VBMPS
- Period
  - 2017-18
  - More VAPs will be planned in 2018-19 from the savings of the sub projects.

## **Conducting Village Awareness Programme**



### > Participants

Milk Producers/ Field functionaries (LRP, DCS Secretary, AI Technician etc.)/ EIA Officers

#### > Facilitators

 LRP/ Technical Officer/ Trainer/ DCS Secretary/ Supervisor/ Veterinarian of Milk Union/ EIA Officers etc.

#### > Selection of Site

centrally/nearby located, easily accessible to participants

## **Funding**



- ➤ 4 Village Awareness Programme per EIA covering at least 40 villages
- > Participation of around 500 milk producers per programme.
- Expenditure per programme may not exceed Rs. 57000/-.
- ➤ Tentative cost heads: Extension material, Kits, Food/ Refreshments, felicitation of milk producers/field functionary, Rent of hall, audio-visual, sitting arrangements etc.
- ➤ EIAs to claim the actual expenditure or Unit Cost (whichever is less) under the FUC as a separate line item "PML- Village Awareness Programme".
  - RBP + VBMPS : claim in VBMPS I sub project
  - Only RBP : claim in RBP I

#### **Process**



- ➤ EIAs to select the villages where RBP and/or VBMPS activities under NDP I are being implemented.
- ➤ EIAs to arrange for the resource persons in coordination with the DCS Secretary/ LRP
- During the programme, videos/ presentations developed by NDDB/ EIAs on NDP I activities may be shown
- Proceedings of these programmes along with the list of participants need to be recorded by EIA personnel and kept in EIA records
- > Summarised list of number of awareness programmes conducted by EIAs along with the number of participants in each of the programme and photographs need to be shared with the monitoring officers every month.
